A motion to approve the consent agenda (no minutes due to strategic planning from June meeting) was made by Jon Halbgewachs and seconded by Kregg Clarke.

The dashboard was reviewed with no questions.

Executive Director Report:

- Though declined for the Rural Mural Grant we submitted, the Holyrood mural will continue and is being coordinated by Grow Ellsworth County with private funds and local artist
- The Love Kansas recruitment program has launched and we will be receiving \$5000 from the Dept of Commerce for being a pilot community. This effort is to recruit people with roots in Kansas, known as "boomerangs" to return to Kansas. The grant is for marketing funds to promote the program. A launch event has been coordinated with Cowtown Days targeted at alumni. They can receive a free meal at the Concert at the Park by registering and giving us the name and contact information of one person we can connect with on their behalf and provide a testimonial on why they should consider returning to Ellsworth County.
- The make My Move program is also live, with additional local benefits being added. The cash incentive for a new remote worker to move here is \$5,000.
- 2 new loan projects are pending approval: 1) Zeal Salon, and 2) Kanopolis Drive In Retracted.
- Lemonade Day is August 5. There are currently 6 participating youth entrepreneurs. We will also be hosting a dog adoption that day in partnership with the Golden Belt Humane Society
- 2 businesses were submitted to the To The Stars Award program
- Bed Tax allocations will be reviewed and recommended tomorrow night
- Leadership Ellsworth County starts in September
- Golf tournament is August 10. We need more board members to volunteer.
- The new website design is complete and has been launched.
- 2 new student board members have been selected and will join us next month, Braydon Halbgewachs and Josie Kueser
- Camp Invention numbers were shared: Holyrood: 25 campers, Wilson: 38 campers, Ellsworth 44 campers
